Village Board Resolution 03-2025
Village of DeRuyter to establish Capital Improvement Reserve Fund

- WHEREAS the Village Board of Village of DeRuyter has determined that it is prudent financial management to
 accumulate cash for future expenditures, to plan ahead and systematically save moneys for future capital
 improvements needed for the Village Office Building/ Fire House; and
- WHEREAS the Village Board of Village of DeRuyter has determined that such prudent financial management
 can reduce or eliminate interest on borrowed funds and other costs associated with debt issuance and reduce
 the risk of sharp increases in the annual budget; and
- WHEREAS the Village Board of Village of DeRuyter has the ability to exercise such prudent financial management by establishing capital reserve funds pursuant to New York State General Municipal Law; and
- WHEREAS the Village Board of Village of DeRuyter has determined that it is in the best interests of the Village
 of DeRuyter to establish a Capital Improvements Reserve Fund for the future capital expenditures for Capital
 Improvements needed for the Village Office and Fire House.
- NOW, THEREFORE, IT IS HEREBY RESOLVED, that pursuant to Section 6-g of the General Municipal Law, as
 amended, there is hereby established a capital reserve fund to be known as the "Capital Improvements
 Reserve Fund" (herein after "Capital Improvements Reserve Fund"). The purpose of this Capital
 Improvements Reserve Fund is to accumulate moneys for capital expenditures in connection with the
 buildings and real property needed for the Village Office/Fire House; and
- IT IS HEREBY FURTHER RESOLVED that the chief fiscal officer of the Village of DeRuyter is hereby directed to deposit and secure the moneys of this Capital Improvements Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Village Board of Village of DeRuyter may invest the moneys in the Capital Improvements Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Village of DeRuyter. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Capital Improvements Reserve Fund. The chief fiscal officer shall account for the Capital Improvements Reserve Fund in a manner which maintains the separate identity of the Capital Improvements Reserve Fund and shows the date and amount of each sum paid into the Capital Improvements Reserve Fund, interest earned by the Capital Improvements Reserve Fund, capital gains or losses resulting from the sale of investments of the Capital Improvements Reserve Fund, the amount and date of each withdrawal from the Capital Improvements Fund and the total assets of the Capital Improvements Reserve Fund, showing cash balance and a schedule of investments, if any, and shall, at the end of each fiscal year, render to the Village Board of Village of DeRuyter a detailed report of the operation and condition of the Capital Improvements Reserve Fund; and
- IT IS HEREBY FURTHER RESOLVED, that except as otherwise provided by law, expenditures from the Capital Improvements Reserve Fund shall be made only for the purposes for which the Capital Improvements Reserve Fund is established. No expenditure shall be made from the Capital Improvements Reserve Fund without the approval of the Village Board of Village of DeRuyter and such additional actions or proceedings as may be

required by Section 6-g of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 7 of Section 6-g of the General Municipal Law, and.

- IT IS HEREBY FURTHER RESOLVED that this resolution is adopted within the Village of DeRuyter at the regular board meeting to be held on July 16, CREATING A TYPE OF CAPITAL RESERVE FUND TITLED AS "CAPITAL IMPROVEMENTS RESERVE FUND", TO BE USED FOR FUTURE CAPITAL EXPENDITURES IN CONNECTION WITH THE BUILDINGS AND REAL PROPERTY NEEDED FOR THE VILLAGE OF DERUYTER"
